#### **Terms and Conditions**

#### The Landlord Agrees That:

- 1. The information supplied to TICA is accurate, complete and up to date in accordance with the Australian Privacy Principles.
- 2. The tenants named in the Landlord Request to List form is named as a tenant on the Residential Tenancy Agreement.
- 3. TICA will write to the tenant at their last known address (or forwarding address if provided) notifying them of the listing in accordance with the Australian Privacy Principles.
- 4. TICA will maintain the record for as long as legislation permits
- 5. The landlord will supply:
  - (i) The front page of The Residential Tenancy Agreement; and
  - (ii) The last page of the Residential Tenancy Agreement that includes the landlords and tenants signatures.
- 6. TICA reserves the right to remove any listing that is found to be inaccurate, incomplete or out of date.
- 7. The landlord hereby gives consent to TICA to supply a tenant or TICA members the landlords contact details to discuss the tenants history.
- 8. The cost of \$44.00 (inc. GST) debited from the credit card is per property letting (i.e. all tenants named in the tenancy agreement).
- 9. They will willingly co-operate with other TICA members who make enquiries regarding information contained within the database.
- 10. They will not enter into arrangements with a tenant that may involve TICA or the TICA system without the prior written consent of TICA.
